AERONAUTICAL INFORMATION PUBLICATIONS

Period of validity: from 01 FEB 2018 to 01 MAR 2018

1 PRELIMINARY ARRANGEMENTS

1.1 PURPOSE

The purpose of this Aeronautical Information Circular (AIC) is to inform the updates recently implemented in our aeronautical information publications, and provide clarification to related issues.

1.2 SCOPE

The provisions set forth in this AIC shall apply to all units and partners of the Brazilian Airspace Control System (SISCEAB), and users who consult or make use, in their operational routine, of aeronautical information publications.

2 AIS PUBLICATIONS IN FORCE

2.1 The Department of Airspace Control (DECEA) is distributing the following publications, which had significant modifications to their content, dated 21 DEC 2017, with effective date 01 FEB 2018:

- AIP AIRAC AMDT - 26/17
- AIP-MAP AIRAC AMDT - 26/17

2.2 THERE WAS NO UPDATE of aeronautical publications in the following amendments:

- COMMON AMDT dated 18 JAN 2018 with effective date 01 FEB 2018.
- AIRAC AMDT 25/17 dated 07 DEC 2017 with effective date 01 FEB 2018.
